In October 2024, the <u>Ontario government announced a \$200 rebate</u> for people residing in Ontario. The intention of the rebate is to compensate families paying high interest rates and the federal carbon tax.

Individuals who pay tax in Ontario will each receive \$200 plus another \$200 for each child in an eligible family. For example, a family of five, including two adults and three children, will receive \$1,000.

To be eligible, people over 18 years of age as of December 31st, 2023 must have filed their 2023 Income Tax and Benefit Return by the end of 2024. Families who qualify for Canada Child Benefit (CCB) payments for 2024 will also receive an additional \$200 for each eligible child under 18 years old.

For circumstances where there exists a shared custody arrangement for a child, payments will be split based on the most recent CCB information available.

For families with children who did not receive the CCB for 2024, the government will provide an opportunity for a taxpayer rebate payment of \$200 per child through an alternative process.

This rebate will be mailed out in early 2025.

## **OTHER NEWS**

#### **Capital Gains Inclusion Rate**

Earlier this month, the CRA updated its guidance to say that it intends to administer the proposed 66.7% inclusion rate effective retroactively to June 25, 2024, even though the proposed changes haven't received parliamentary approval. The CRA said this is consistent with its standard practice.

The CRA also said it would provide arrears interest and penalty relief to corporations and trusts that had to file a return on or before March 3, 2025, without the benefit of having access to updated CRA forms reflecting the new inclusion rate.

The CRA is expected to publish updated forms by the end of January, 2025.
